Rudget allotments of a number of officers were brought down in the light of the average actual expenditure of the offices for the picylous 9 years. Uniform standard of procedure in the district offices and standardization of a number of registers maintained in the offices as well as a reduction of the periodical reports sent out by subordinate offices parti quiarly in the mofussil have also been achieved through the inspections by the Chief Inspectorate of Offices Apart from the above Government have been able to detect major and minor irregularities obtaining in certain offices and um eduately rectafy them. There has been a general improvement in almost all the offices inspected not only in the methol of dealing with cases but also in the out turn of work and deposals
