Sri G. Raja Ram was first elected to the former Hyderabad Legislative Assembly in 1952 and was Leader of the Socialist Party; he was in the forefront of "Quit College" movement in the *earst-while* Hyderabad State in 1947. He was a member of the Land Commission. He continued to be a member of the Andhra Pradesh Legislative Assembly from 1962 till his demise in 1981. He was elected unopposed to the Andhra Pradesh Legislative Assembly from Balakonda Constituency in 1967. He was for sometime General Secretary of Telangana Praja Samithi. From 1972, he was a Minister in the Cabinets of Sri P. V. Narasimha Rao, Sri J. Vengala Rao, Dr. M. Channa Reddy and Sri T. Anjayya and held the portfolios of Handlooms, Co-operative Textile Mills, Co-operative Sugar Factories, Finance and Power with distinction. He was 56 when he passed away on the 10th May, 1981.

As a mark of respect to the departed soul let us stand and observe two minutes silence.

This House places on record its deep sense of sorrow at the demise of Sri G. Raja Ram, Minister and Member of the Andhra Pradesh Legislative Assembly and conveys its deep sense of sympathy to the members of the bereaved family.

Mr. Deputy Speaker :— Sri Parakala Seshavataram was first elected to the Andhra Pradesh Legislative Assembly in 1962 and continued as a member till his demise in 1981. He was a Minister in the Cabinets of Sri J. Vengala Rao, Dr. M. Channa Reddy and Sri T. Anjayya. He was holding Panchayati Raj Portfolio in his last days and he strained very much for successfully conducting elections to Panchayati Raj Bodies. He represented the Narsapur Constituency of the West Godavari District. He breathed his last on the 11th July, 1981.

This House places on record its deep sense of sorrow at the demise of Sri P. Seshavataram, Minister and Member of the Andhra Pradesh Legislative Assembly and conveys its deep sense of sympathy to the Members of the bereaved family.

Mr. Deputy Speaker:—Sri D. Venkatapathi was elected to the Andhra Pradesh Legislative Assembly from Allavaram Scheduled Castes reserved constituency in East Godavari District in 1978. He passed away on the 28th July, 1981.

As a mark of respect to the departed soul, let us stand and observe two minutes silence.

The Question is:—

This House places on record its deep sense of sorrow at the demise of Sri D. Venkatapathi, Member of the Andhra Pradesh Legislative Assembly and conveys its deep sense of sympathy to the Members of the bereaved family.

The motion was adopted *Nem Con* all members standing.

Mr. Deputy Speaker:—Sri Sagi Suryanarayana Raju was a member of the Composite Madras Legislative Assembly from 1952. He was a member of the Andhra Pradesh Legislative Assembly from 1957–1962; 1967 to 1978. He was a Minister in the former Cabinet of Sri Vengala Rao. He was the first Chairman of the Visakhapatnam Zilla Parishad from 1959 to 1962. He was also the former President of Visakhapatnam District Congress. He was 78 when he passed away on 14th August, 1981.

As a mark of respect to the departed soul, let us stand and observe two minutes silence.

The question is:—

This House places on record its deep sense of sorrow at the demise of Sri Sagi Suryanarayana Raju, former member of the Andhra Pradesh Legislative Assembly and conveys its deep sense of sympathy to the members of the bereaved family.

The motion was adopted *Nem Con* all members standing.

Mr. Deputy Speaker:—Sri Allu Dasavataram represented *Jami* Constituency of the Visakhapatnam District from 1962 to 1967. He was a member of the undivided Congress. He was sixty years old when he died on 10th October, 1981.

He was holding the office of the Presidentship of the Kanekal Co-operative Rural Bank and at the age of 67, he passed away on the 12th September, 1981.

As a mark of respect to the departed soul, let us stand and observe two minutes silence.

This House places on record its deep sense of sorrow at the demise of Sri L. Chinnapa Reddy, former member of Andhra Pradesh Legislative Assembly and conveys its deep sense of sympathy to the members of the bereaved family.
