SRIS, JAIPAL REDDY (Kalvakurthy) :- Mr. Speaker, Sir. My voice is choked with emotion and my mind is dim with clouded memories. Acharya Kripalani Ji was not only our oldest living leader, but since he was a nonagenarian he was also our most venerable and revered leader. His life was a saga of struggle and song of sacrifice. It may be recalled that Acharya J. B. Kripalani was the only leader of the Pre-Independent Congress who was the General Secretary of the Indian National Congress for twelve successive years. When he was the President of the Indian National Congress, we, Indians, attained Independence So, to put in a nutshell, Acharya Kripalani was the last immortal of Independence struggle. We have still many freedom fighters in the country, but he was the last leader who achieved the national eminence during the freedom struggle. He was also the only old guard congressman, who after independence never adorned any office. He was the stranger in the corridors of power. There were also other giants like Acharya Narendra Dev and Java Prakash Narayan, who while being flaming freedom fighters, never tasted the office in free India. But within the Congress, they belong to Congress Socialist Party. But Acharya Kripalani was the only old guard Congressman, who after attainment of Independence also, never tasted the office. Even at the advanced venerable age of 94, he retained sharp mind. He had not only a sharp mind, but had a sharper tongue. His witty tongue overrules the ridicule on the rule that followed the freedom of this country. He was a veteran parliamentarian. I still remember very distinctly, that when I was a student, I had been inspired by the epic parliamentary jewels that engaged Pandit ji in the wake of Chinese Aggression. One of the most moving moments, in my own humble life, was when Acharya Kripalani ji, broke down at the funeral of Jayaprakash Narayan. When Jayaprakash Narayan died, we still look forward for this polished Indian after Jayaprakash Naryan. I am bringing to your notice that Acharya J B. Kripalani Was the co-architect of Janata Party along with Jayaprakash Nara-Of all the leaders living in the country, Kripalani, with the life of suffering, sacrifice and struggle, symbolised purity in the public life. Sir, though he was a great puritan, he was also a great fatalist. He had a powerful sarcasm. I was in Bombay yesterday to attend the National Executive Meeting of Janata Party where our leader, Mr. Madhu Dandavate was referring to one expression that Acharyaji used with reference to God in the last days of his life. The sarcastic tongue did not even spare God. Acharyaji, in the last years of his life was so depressed and gloomy. He felt that it is long to leave this world. In that mood he appears to have said "Why this wretched God not put me up?" That was the mood in his last days. The only tribute we can pay to this noble departed

soul is to live true to the ideals, values and norms that symbolised and epitomised in his career and life. The only lasting memory towards greatmen like this, is the continuing vitality of Indian Democracy. With these few words, I associate myself with the Motion which the Chief Minister moved.

- (a) Yes Sir.

FILLING UP OF CRAFT POST WITH P.E.T. TEACHER IN Z.P. HIGH SCHOOL, PALKEEDU.

- *8045 (Y) Q.—Sri N. Raghava Reddy (Nakrekal) Smt. M. Swarajyam and Sri M. Omkar: Will the Minister for Education be pleased to state:
- (a) whether it is a fact that authorities of Zilla Parishad, Nalgonda made irregular appointments;
- (b) whether it is also a fact that the Craft post was filled with P. E. T. teacher in Zilla Parishad High School, Palkeedu;
 - (c) the number of such irregular appointments made; and
 - (d) if so, the reasons therefor?

Answers to questions placed on the Table.

A---

- (a) If the period is furnished necessary information will be gathered;
- (b) Yes Sir. In January 1981 only in one case, a P. E. T. was adjusted agianst the post of a Craft teacher for a temporary period of about two months.
- (c) & (d): The Zilla Parishad, Nalgonda advertised for 14 vacancies of P. E. Ts., in December 1980. The District Selection Committee selected 14 candidates and placed 4 additional names in panel on 3-1-1981. By that time one P. E. T., on long leave, joined duty. Hence there were only 13 vacancies against the 14 candidates selected. In the usual course the 14th person should have been left out but since 13 and 14 are ladies and only ladies have to be appointed for girls Schools they were absorbed and the Management could not drop a person higher in the list of merit than the lady teachers. Hence, for a temporary period of about two months a male Physical Education Teacher was adjusted in Craft teacher's post which was vacant at Zilla Parishad High School, Palkeedu and immediately after a vacancy of P. E. T., arose in Z. P. High School, Nampally, he was transferred and a regular Craft Teacher was posted in the vacancy of Craft Teacher.

- *8261-Q.— Sarvasri Ch. Parsuram Naidu (Parvathi Puram) and P. Sriram Murthy (Amadalavalasa):- Will the Minister for Education be pleased to state:
- (a) whether Sri Narapu Balakrishnamma, M.L.C. submitted several complaints of malpractices against Sri Raghavendra Swamy District Educational Officer, Srikakulam;
- (b) if so, whether an enquiry was made, and what is the course of action taken; and
- (c) the action taken on the Kondareddi Enquiry report against the District Educational Officer?

- (a) Yes Sir.
- (b) (I) A preliminary enquiry was conducted by Sri Ramachandra Pillai, Deputy Director of School Education and a prima facie case was found regarding
- (i) irregular admissions to Government Teachers Training Institute, Umaravalli, Srikakulam Districti

- (ii) delay in absorption of a teacher;
- (iii) Grant of exemption to aided school teachers working in Aided Elementary Schools in Badragiri Samithi against the recommendation of Deputy Inspector of Schools.

Hence he was suspended and a regular enquiry was ordered.

- (II) The allegation of corruption was enquired into by Anti Corruption Bureau which found it not substantiated. The Anti Corruption Bureau recommended the dropping of further action and the Vigilance Commission concurred in it. The Government dropped further action.
- (III) Meanwhile he was reinstated, on the representations of his wife and himself and the report of the Collector.
- (c) Sri Konda Reddy's enquiry was not against Sri Raghavendra Swamy, the District Educational Officer.

In order to improve voltages in the area, a sub-station at Bib nagar is being established and it is now under construction. The sub-station is programmed to be commissioned by the end of 3/82.
- (b) and (c) Only one industrial connection of a 50 H.P. load was given supply It is a hatcheries unit set up under Small Scale Industry under priority sector. It was financed by the Andhra Bank, Bhongir It supplies chicks to small farmers, marginal farmers, weaker sections and educated un-employed in Nalgonda and Khammam districts. In view of the urgency and

importance of the hatcheries to small farmers, a booster was crected on the feeder as a temporary measure, till the materialisation of sub-station at Bibinagar, so that the other existing agricultural loads on the feeder are not affected due to release of supply to the hatcheries. Even after erection of the booster, still tail end voltages are poor (13-22%). It is, therefore, not possible to release agricultural loads with the booster.

The agricultural loads of Gudur and Pagidipally will be given supply, after commissioning of the sub-station at Bibinagar, subject to completion of other formalities by the ryots
