*7-Q-Sri G. Vijaya Rama Rao:- Will the Chief Minister be pleased to state:

(a) the extent of surplus land available under Urban Land (Ceiling and Regulation) Act, 1976 in Hyderabad, Vizag, Vijayawada and Tirupathi; and

(b) the extent of land held in excess by the private firms, industries in contravention of the Act.

A.-(a) The extent of surplus land available is as follows:

1. Hyderabad 4,27,200 sq.mts.,
2. Vizag 85,200 sq. mtrs.,
3. Vijayawada 9,200 sq.mtrs., Urban land (Ceiling and Regulation) Act, 76 is not applicable to Tirupathi.

FOR SETTING UP K.T.P.S.**

*37-Q-Sarvasri Ch. Vidyasagar Rao, Vañka Satyanarayana and S. Chandra Mohan Reddy:- Will the Chief Minister be pleased to state:

(a) whetehr it is a fact that the Government is contem-
plating to revoke the permission accorded to the G.V.K. Group
to set up Krishnapatnam Thermal Power Station; and

(b) if so, the reasons therefor?

A.-(a) No, Sir.

(b) Does not arise.

GROUND WATER POLLUTION IN HYDERABAD CITY

*543-Z(S)-Q.-Sri D. Chinna Mallaiah:- Will the Chief
Minister be pleased to state:

(a) whether it is a fact that the ground water in several
areas of Hyderabad City has been polluted;

(b) whether the residents of Gayathripuram has submitted
any representation in this regard;

(c) if so, the steps taken to prevent the pollution; and
to supply protected drinking water to such areas?

A.-(a) Yes Sir.

(b) No, Sir.

(c) Due to Industrial and domestic effluents the ground
water in several areas of Hyderabad City has been polluted.
Areas such as Qutubullapur, L.B. Nagar, Sanathnagar and
Nacharam have been polluted due to Chemical and Drug Indus-
tries. Being shall small units, they are unable to set up
individual treatment plants due to financial constraints.

To overcome the problem, the concept of Common Effluent
Treatment Plant system to treat the effluent generated from
Small Scale Industries has been evolved by constructing and

commissioning such a system at each of the Jeedimetla, Patancheru and Bollaram Industrial Estates. Under the approved scheme, the State and Central Governments contribute 50% of the project cost as a subsidy subject to a maximum amount of Rs.50.00 lakhs each for each project.

Industrial and Domestic effluents of Balanagar and Jeedimetla areas have been discharged into Kukatpally Nallah which joins Hussainsagar Lake causing ground and surface water pollution. To solve this problem Hyderabad Metropolitan Water Supply and Sewerage Board has laid a duplicate K & S main pipeline to convey the effluents from Kukatpally to Amberpet sewage treatment plant. The cost of this project is Rs. 14.00 crores. A pipeline is also proposed to discharge the treated effluents of Jeedimetla Common Effluent Treatment Plant into the duplicate K & S main. The cost of this project is Rs.1.00 Crore.

A pipeline was laid by M/s. SIRIS to discharge the treated effluents of their factory into Municipal Sewer which ultimately joins Musi River.

Andhra Pradesh Pollution Control Board is monitoring all the polluting industries located in and around twin cities and action was taken against 17 industries, for violation or directions of the Board during the year 1993 and 1994 and studies have been taken upto dispose of the hazardous waste in a secure manner as Government has come forward to extend financial help of Rs. 14.00 crores. The Government share for this scheme is Rs. 3.3 crores. The total cost of the project is Rs.17.3 crores.

Regarding drinking water supply to such areas, concerned Municipalities are making efforts to meet the demand.

LEAVING OF TAX ON CABLE T.Vs.

*544-Q.-Sarvasri K. Subba Raju and Venkata Satyanarayana: Will the Chief Minister be pleased to state:

(a) whether it is a fact that film industry has sustained heavy losses due to the increase of Cable T.V., Master Channels etc., in the State;

(b) whether it is a fact that the Government and the local bodies are loosing income heavily due to these channels; and

(c) whether there is any proposal with the Government to get additional income from these channels which are earning profits from advertisements on a large scale?

A.-(a) Yes, Sir.

(b & c) A legislation has been brought out amending the Andhra Pradesh Entertainments Act by Act 32/95 providing for levying tax on Cable T.V. Service. The estimated revenue on levy of tax on Cable T.V. Services would be Rs. 10 crores per annum approximately.

RESERVATIONS TO MUSLIM COMMUNITY

*925-Q.-Sri Asaduddin Owaisi:- Will the Chief Minister be pleased to state:

(a) whether it is a fact that the Government of Karnataka has made reservations for Muslim Minority Community for the purpose of appointments and admission of Professional Colleges vide its G.O.No. SWD/BCH/90/150, dt. 17th September, 1994 in the light of judgement pronounced by the Supreme Court of India on 9th September, 1994 as appeared in 'Siasat' Daily Urdu Newspaper; and

(b) whether the Andhra Pradesh Government is considering this issue and extend such facility to the Muslim Minority with some other suitable benefits?

A.-(a) Details from Government of Karnataka are awaited.

(b) Government will take a suitable decision as soon as the details are received.

LAND ALLOTMENT TO HINDUJA COMPANY

*1066-A.-Sarvasri B. Satyanarayana Murthy, P. Saralah and S. Venkateswara Rao:- Will the Chief Minister be pleased to state:

(a) the extent of land allotted to Hinduja Company for setting up of 1000 MW power station at Wadacheepurupalli in Visakhapatnam District;

(b) whether it is a fact that the said Company has made a request for 1000 acres of additional land; and

(c) the time by which the said project will be grounded and completed?

A.-(a) No land has as yet been handed over to M/s. Hinduja National Power Corporation Limited.

(b) The company has placed requisition for 2606.33 Acs.

(c) As per the indications given by M/s. Hinduja National Power Corporation Limited, the project work is likely to commence around June, 1996. The 1st 500m MW Unit is expected to be commissioned in 38 months and the second 500 MW unit in 44 months from the date of financial closure.

ENVIRONMENTAL POLLUTION

*1227-Q.-Sri P. Purushotham Rao:- Will the Chief Minister be pleased to state:

(a) whether it is a fact that the environmental pollution is caused due to emission of dust from the transportation of thousands of lorries loads of coal to N.T.P.C., Kesoram Cement Factory and Andhra Pradesh State Electricity Board between Ramagundam and Godavari Khani in Karimnagar District;

(b) whether it is also a fact that thousands of people, are subjected to ill health because of this pollution; and

(c) if so, the steps taken to prevent the pollution?

A.-(a) & (b):- No, Sir.

(c) Does not arise.

MULTIPURPOSE IDENTITY CARDS

*1292-Q.-Sarvasri B. Narasimhulu, K. Viswanatham, P. Singanna Dora, S. Venkateswara Rao, A. Brahmaiah, Y. Srinivasula Reddy and G. Veera Siva Reddy:- Will the Chief Minister be pleased to state:

(a) whether the Government propose to issue Multipurpose Identity Cards;

(b) whether the Election Commissioner has approved the said cards; and

(c) if so, the time by which Multipurpose Identity Cards will be supplied?

A.-(a) Yes, Sir.

(b) Yes, Sir.

(c) After completion of the data entry and finalising the data base, the multipurpose identity cards will be issued.

"ZERO MAAL" BUSINESS BY RICE AND OIL MILLERS IN KARIMNAGAR ETC.

*1366-Q.-Sri D. China Mallaiah:- Will the Chief Minister be pleased to state:

(a) whether it is a fact that some of the rice and oil millers in Karimnagar, Jammikunta, Huzurabad Towns are carrying on 'Zero Maal' business; and

(b) if so, whether any surveillance has been kept on such millers; if so, the result thereof?

(a) Yes, Sir.

(b) Inspection of certain Rice Mills and Oil Mills are being taken up on the information gathered from market and also from check posts. The way bills collected are being verified, Surveillance is kept and steps are invited to curb evasion of tax.

PROVISION OF EMPLOYMENT TO THE DISPLACED
PERSONS IN VISAKHAPATNAM STEEL PLANT

*1476-Q.-Sarvasri P. Nageswara Rao, M. Anjaneyulu and V. Abbaiah:- Will the Chief Minister be pleased to state:

(a) whether it is a fact that nearly 8000 people possessing 'R' cards among the educated displaced in connection with the construction on the Visakhapatnam Steel Plant have not been provided with jobs as promised: and

(b) if so, the steps taken to provide them jobs?

A.-(a) Yes, Sir.

(b) The Visakhapatnam Steel Project provide employment to 6246 displaced persons so far. They also reported that at present there is no scope for further recruitment of displaced persons. A Committee with Officials and non-officials has been constituted to explore the employment opportunities to the displaced persons. The Committee resolve' that the displaced persons are to be provided training to improve their skills and employability, for keeping a pool of candidates for future employment. As many of 32 items of works on contract in Visakhapatnam Steel Plant were identified, which can be entrusted to the displaced persons. The Steel Plant authorities have promised that the displaced persons would be provided with employment as and when vacancies arise.

WIND POWER PROJECTS

*1584-Q.-Sarvasri G. Veera Siva Reddy and M. Kodanda Reddy:- Will the Chief Minister be pleased to state:

(a) the number of applications received by the Government for permission to set up wind power projects in the State, the number of applications in respect of which permission was accorded and the number out of them started;

(b) the concessions and incentives provided by the Government to the industrialists who come forward to establish wind power projects; and

(c) whether additional concessions are being given to the NRI Industrialists in this regard; if so the details thereof?

A.-(a) 118 applications were received from the private entrepreneurs for allotment of wind power projects in the State. Permissions were accorded to 70 private entrepreneurs. 10 private organisations have already commissioned their projects.

(b) The following are the incentives issued by the Government in G.O.Ms.No. 147, Energy(RES) Department, dt. 15.11.1995 to encourage the private entrepreneurs to set up wind power projects:

(1) The wind power projects will be eligible for capital subsidy to the extent of 20% of the project cost, subject to a ceiling of Rs. 25 lakhs.

(2) Whenever Government land is identified, the same will be alienated to Non-Conventional Energy Development Corporation of Andhra Pradesh Ltd (NEDCAP), which in turn would allot the land to the developer at market value, subject to the condition that the land is not used for any purpose other than for setting up a wind energy farm, and any other conditions as may be prescribed by Government from time to time.

(3) The applications from the developers for Government land will be considered on a first-come-first-serve basis.

(4) The developer will be eligible for allotment of Govt. land for a maximum capacity of 20 MW. For capacity exceeding 20 MW, the developer will have to establish the project in private land.

(5) Purchase of wind energy would be at Rs.2.25 Ps. per unit and the escalation will be permitted as per the formula worked out by the A.P.S.E. Board.

(6) Wheeling charges will be at a concessional rate 2% of the energy fed to the grid and the percentage of wheeling charges to be collected after five years will be reviewed and finalised before December, 2000 A.D.

(7) Developers will be able to bank the energy generated at the wind power stations with the A.P.S.E.B. for a captive consumption or for sale to third party. Banked energy will be permitted to be utilised for all 12 months, in case the energy is used for captive consumption. In regard to third party sale, banked energy will be permitted to be utilised from the months of August to March only. A fee of 2% of energy banked will be collected as banking charges.

(8) Regarding sale to third party, the rate of sale will be necessary higher than the HT-1 tariff as fixed by APSEB. These sales would be subject to having only five consumers for every 1 MW capacity.

(9) Power evacuation facilities will be created by APSEB. by collecting evacuation facility charges of Rs. 10 lakhs per MW from the developer.

(c) No sir, Does not arise.

COMPUTERISATION ADMISSION PROCEDURE FOR EAMCET

*1630-Q-Sarvasri Koneru Nageswara Rao and Ch. Vidyasagar Rao:- Will the Chief Minister be pleased to state:

(a) whether the Government are aware of the system adopted at the EAMCET-1995, counselling Session in respect of the Engineering admissions;

(b) whether it is not a fact that there is lack of provision for the candidate to exercise his option in writing well in advance; and

(c) whether computerised admission procedure would be introduced to avoid such lacanacy.

A.-(a) Admissions to the various courses in Engineering, Technology and Pharmacy in the State are made in accordance with the procedure prescribed in G.O.Ms.No. 184, Edn.(Ec.2) Dept., dt. 20-8-1993.

Candidates who have secured ranks at the Entrance Test are called for an interview in the order of Merit for Selection and allotment of course/branches/instructions. For the convenience of the candidates, representatives of all University Professional colleges, Regional Engineering Colleges, Warangal and Private Professional Colleges in the State sit in a common admission room. As and when a candidate gets her/his turn for interview in the order of merit, choice of institutions and branch/course of study) will be given to him depending upon the availability of seats at the point of time with due regard to the eligibility of the candidate for a seat in a particular local area for a particular reserved category.

(b) There is no provision for the candidates to exercise his options in writing well in advance.

(c) Computerised EAMCET procedure is very desirable and the Government is contemplating to advise the Andhra Pradesh State Council of Higher Education to adopt the procedure from next academic year.

IMPOSING OF CONSIGNMENT TAX ON GOODS

*1655-Q-Sri Gadde Babu Rao:- Will the Chief Minister be pleased to state:

(a) whether the Government is aware that traders are evading sales tax by sending the goods of one State to other as a consignment in the name of agents; and

(b) if so, whether the State Government will prevail upon the Central Government to impose consignment Tax and distribute the same among the States?

A.-(a) Yes Sir.

(b) Due to constitution (46th) Amendment Act entry 92-D in list-I of Seventh Schedule of the Constitution was incorporated. As a result Parliament is empowered to make law. But no act has been passed by Parliament levying tax on consignment of goods.

AGREEMENT BY A.P.I.D.C. FOR PRIVATISATION OF KAKINADA PORT

*1748-Q-Sri Mutha Gopala Krishna:- Will the Chief Minister be pleased to state:

(a) whether it is a fact that as a part of the Privatisation in Kakinada Port, the Andhra Pradesh Industrial Development Corporation has entered into an International Agreement worth ₹.350 crores; and

(b) if so, the details thereof?

A.-(a) No Sir,

(b) Does not arise.

MISAPPROPRIATION IN FOREST DEVELOPMENT CORPORATION

*1753-Q-Sarvasri Baddam Bal Reddy and P. Rama Swamy:- Will B. Laxmana Rao:- Will the Chief Minister be pleased to state:

(a) whether it is a fact that about 90 lakhs of rupees were misappropriated in the Forest Development Corporation in the purchases and creation of new divisions for the Corporations; and

(b) if so, the action taken against the persons responsible for the same?

A.-(a) No Sir. However during the course of Accountant Generals Audit, it was observed that an expenditure to the tune of ₹.41.931 lakhs could have been avoided in purchase of Bio-chemicals and fertilizers by Andhra Pradesh Forest Development Corporation during 1994.

Further during December, 1994 the Vice-Chairman and Managing Director decided to revive(6) old divisions under the proposed new schemes, out of which (3) were kept in advance due to administrative reasons. The decision also involved purchase of (2) vehicles at a cost of about ₹.5,30,000/-.

(b) Government has referred the matter to the Anti-corruption Bureau for further enquiry. Its report was received and the matter is now referred to Andhra Pradesh Vigilance Commissioner and his report is awaited. Necessary further action will taken after the receipt of the same.

LOSSES IN A.P. NON-RESIDENT INDIAN INVESTMENT CORPORATION

*1766-Q-Sarvasri K. Yerram Naidu, A. Brahmanaiah and B. Laxmana Rao:- Will the Honourable Chief Minister be pleased to state:

(a) whether it is a fact that as per the annual reports of the Andhra Pradesh Non-Resident Indian Investment Corporation for the years 1991-92 and 1992-93 submitted to the Assembly in 1995 the said Corporation is running on losses of ₹.60,10,317.01;

(b) whether it is a fact that there is no provision in the Budget for the payment of penal interest of ₹.68,214.55 to the State Government;

(c) whether it is a fact that there is no possibility of recovering the loan amount of ₹.4,92,966.00 and interest of ₹.5,73,510.30 from the Bimetallic Company as it is in financial crisis; and

(d) whether there is any proposal to extend financial assistance to the said Company to tide-over the financial crisis?

A.-(a) No, Sir. The loss for the years 1991-92 and 1992-93 was ₹.41,07,981.44 but not ₹.60,10,317.01.

(b) Yes, Sir.

(c) M/s. Bimetallic Steels and Alloys Limited was not sanctioned any loan.

(d) No, Sir.

PLYING OF CONTRACT CARRIAGES IN THE STATE

*1774-Q-Sri Koneru Nageswara Rao:- Will the Chief Minister be pleased to state:

(a) whether it is a fact that Andhra Pradesh Road Transport Corporation is incurring losses due to plying of contract carriages in the State;

(b) the number of contract carriages so plying; and

(c) the action proposed to be taken to prevent the losses being occurred to the R.T.C.?

A.-(a) Yes, Sir.

(b) It is reported that the following contract carriages are operating in the notified routes of the Corporation:

(1) 114 All India Tourist Vehicles.

(2) 125 State-wide contract carriage permit vehicles.

(3) 900 District-wise contract carriage permit holding vehicles.

In addition to this, there are about 2000 other vehicles i.e., Jeeps, Maxi-cabs, Matador Vans etc. are plying on the notified routes of the Corporation.

(c) The Corporation is pressing additional services on the routes where illicit operation is rampant. The Corporation is constantly pursuing with the Transport Authority at State level and District level duty furnishing the details of vehicles plying illicitly on the notified routes of the Corporation and requesting them to take steps to arrest illicit operations.

LOW VOLTAGE PROBLEM IN ANANTHAPUR DISTRICT

*1815-O-Sarvasri K. Gadi Lingappa, K. Parakrishna and T.D. Nagaraja Reddy:- Will the Chief Minister be pleased to state:

(a) whether it is a fact that A.P. State Electricity Board has prepared a comprehensive scheme to solve the low voltage problem in Ananthapur District;

(b) whether it is a fact that co-operation was sought from Japan to implement this scheme; and

(c) if so, the time by which it will be implemented?

A.-(a), (b), (c):- Sir, A proposal for seeking assistance of Yen has been prepared and submitted to O.E.C.F., Japan for sanction O.E.C.F. has agreed to sanction the Gooty and Ananthapur System for the project deleting the Hindupur System from the original proposal. Implementation of the scheme is expected to be completed within 2 years from the date of the drawal of the 1st Instalment of the loan amount.

MINI POWER GENERATION PLANTS IN JEEDIMETLA

*1860-Q-Sarvasri K. Yerran Naidu, G. Veera Siva Reddy, A. Sudarshan and A.J.V.B. Maheswara Rao:- Will the Chief Minister be pleased to state:

(a) whether the State Industrial Development Corporation has submitted proposals to the Government to set up 25 to 30 MW capacity Mini Power Generation plants at a cost of Rs.100 crores in the Industrial Estate, Jeedimetla; and

(b) if so, the stage at which the matter stands at present?

A.-(a) No, Sir.

(b) Does not arise.

GUIDELINES FOR MINI POWER PLANTS

*1892-O-Sarvasri M. Kodanda Reddy, C.K. Jayachandra Reddy, D. Nagendar, E. Pratapa Reddy and G. Vijaya Rama Rao:- Will the Chief Minister be pleased to state:

(a) whether there is any proposal to start Mini Power Plants in the State; and

(b) if so, the guidelines therefor and the places proposed to set up the said Mini Power Plants?

A.-(a) Yes, Sir.

(b) The guidelines issued on the Mini Power Plant schemes are placed on the Table of the House. As would be seen therefrom the choice of location for setting up the Mini Power Plant is left to the individual entrepreneur.

GUIDELINES ON THE MINI POWER PLANTS PLACED ON THE TABLE OF THE HOUSE VIDE ANSWER TO CLAUSE(B) OF L.A.Q.NO. 1892.

1. The Mini Power Plants (hereinafter called as MPP) will essentially be group captive, dedicated power stations. As such they will generate and supply power to identified consumers, who have entered into agreement with the developers of mini power plants. Such power plants would be best suited to serve customers through a dedicated distribution system, preferably over small compact areas.

2. Prospective investors and entrepreneurs, based on their study of demand conditions, and after finalising negotiations with end consumers of power, for production and supply of power, will draw up their detailed project reports and submit their application to the Andhra Pradesh State Electricity Board in the fastest feasible manner and the licences will be issued in conformity with provisions of the existing Electricity Acts and other statutes, preferably within a period of four weeks from the date of filing of complete application by the developer, and after duly obtaining orders in circulation:

3. Energy from the mini power plants can be supplied to identified consumers using either Andhra Pradesh State Electricity Board's existing distribution net work of setting up a dedicated transmission net work after obtaining a licence under Section (3) of the Indian Electricity Act, 1910. In the case of the former, Andhra Pradesh State Electricity Board may on request, lease out the distribution net work to the developer. Detailed arrangements like lease rent etc., will be worked out on mutually acceptable terms between the Andhra Pradesh State Electricity Board and the Mini Power Plant developers. Similar arrangement can also be finalised for the dedicated net works established by Mini Power Plant developers so as to conform to statutory requirement.

4. Where, however, it becomes necessary for the power generated by the Mini Power Plant to be wheeled using the Andhra Pradesh State Electricity Board transmission net work, wheeling charges will be collected from the developers in kind and as a percentage of the energy delivered at the inter-connection point. The proposed rates of wheeling charges are as follows:

- i. 132 KV consumer - 8%
- ii. 33 KV consumers - 10% for a distance upto 50 KM.
11 KV consumers - 12% for distance between
51 KM and 100 KM.
- &
- LT consumers - 15% beyond 100 KM.

5. Infrastructure like sub-station and the line, if any required for interfacing the mini power plants with the Andhra Pradesh State Electricity Board grid will be erected at the cost of the Mini Power Plant development:

6. In the event of the Mini Power Plants generating power in excess of the requirement of their consumers, the same can be purchased by the Andhra Pradesh State Electricity Board. Such purchases by the Andhra Pradesh State Electricity Board may be upto 15% of individual Mini Power Plant capacity. The Andhra Pradesh State Electricity Board may also purchased power beyond 15% of the Mini Power Plant capacity at Andhra Pradesh State Electricity Board's option, without conferring any pre-emptive right of sale on the Mini Power Plant. The price for supplies made to the Andhra Pradesh State Electricity Board will be weighted average price of purchase of power made by the Andhra Pradesh State Electricity Board from Central and other State Electricity enterprises on a monthly basis. Settlement of accounts will be on a monthly basis. The above procedure would be in force upto the end of December, 2000 AD, and would be subject to review thereafter;

7. The mini power plants would need to undertake scheduled outages for maintenance. Scheduling of a outages of the individual Mini Power Plants will need to be done in co-ordination with Andhra Pradesh State Electricity Board and should be normally scheduled during the period of surplus power in the year i.e., from August to November. When scheduled outages are undertaken as above, Andhra Pradesh State Electricity Board will supply power to the Mini Power Plant, at the then prevailing tariff rates for industrial consumers. For unscheduled breakdown in the supply of power by the Mini Power Plants, subject to availability, Andhra Pradesh State Electricity Board will be willing to supply power to the Mini Power Plant but, at a rate equal to 133% of the industrial tariff then prevailing. The normal outage every year will not

exceed one month in the year. For availing the supply of power during outages the Mini Power Plants developer will need to pay in advance a security deposit equivalent to the estimated consumption of power for a period of 30 days.

8. The Mini Power Plant developer shall necessarily sell power to the consumers above the Board's High Tension tariff rate.

9. Once industrial consumers enter into agreement with the Mini Power Plant developer, their security deposit with the Andhra Pradesh State Electricity Board will be refunded after adjusting the amounts, if any, due from them to the Andhra Pradesh State Electricity Board for the supply of power. Individual consumers can at their option continue to be consumers of Andhra Pradesh State Electricity Board paying minimum charges and maintaining security deposit with a view to obtaining energy supplies from the Andhra Pradesh State Electricity Board net work independent of Mini Power Plants arrangement with the Andhra Pradesh State Electricity Board.

10. The Government of Andhra Pradesh will also recommend to the Government of India for exempting mini power plant equipment from customs duty when imported. The Government will also help the mini power plant developer to obtain preferential treatment in fuel supply allocation.

The matter of loss of certificates was brought to the notice of all the members of Public through local news papers on 25.4.95. On 21.4.95 the loss was informed to Chief Post Master-General/Post Masters General of all other circles. No instance of issuing the missing National Savings Certificates without proper accounting has come to the notice so far. The supply of National Savings securities to all Post Offices in the State is done by the Postal authorities, Government of India. The State Government has no control over the supply of National Savings Bonds to the Post Offices.

Indemnity Bond has been obtained from the official at fault by the Post Master General, Andhra Pradesh, Hyderabad.

**DISTRIBUTION OF INCOME DESIRED THROUGH TAXES
AMONG THE STATES**

*1664-Q-Sri Gadde Babu Rao:- Will the Minister for Finance be pleased to state:

(a) whether the Central Government is not distributing the income derived through the recently levied tax on services among the States;

BLOW OUT IN O.N.G.C. AT DEVARLANKA

*390-Q-Sarvasri Baddam Bal Reddy, Vanka Satyanarayana, K. Subba Raju, K. Ramakrishna:- Will the Minister for Revenue, Relief and Rehabilitation be pleased to state:

(a) the number of people affected due to blow out in O.N.G.C. well at Devarlanka in East Godavari District.

(b) whether O.N.G.c. has agreed to pay compensation to the affected people.

(c) the amount given per Hectare to the damaged paddy crops and coconut groves. and

(d) the number of people provided permanent housing facility.

A.-(a) 1555 Families consisting of 5515 persons were affected due to Gas Blow Out in O.N.G.c. drill site at Devarlanka H/o Bodasakurru village, Amalapuram Mandal.

(b) Yes Sir.

(c) For damaged paddy crop at the rate of 30 bags per acre at Food Corporation of India price of Rs.300/- per bag and for all fully damaged coconut yielding trees at the rate of Rs.216/- per tree. The O.N.G.c. released a total amount of Rs.54,22,012/- in two instalments towards payment of compensation for various damages like crop, coconut, houses etc., for 225 cases under public Liability Insurance Act, 1991. An amount of Rs.43,37,610/- has already paid to the victims and payment of the balance amount towards compensation is being arranged.

(d) It is proposed to provide newly constructed pucca houses to the 300 affected families in Devarlanka, Goplanka and Allavaram villages.

ENQUIRY ON THE MISAPPROPRIATION IN NATIONAL INSTITUTE OF AMATEUR RADIO

*1357-Q-Sarvasri P. Nageswara Rao, N. Anjaneyulu and V. Abbaiah:- Will the Minister for Revenue, Relief and Rehabilitation be pleased to state:

(a) whether it is a fact that the enquiry ordered into the misappropriation of Rs.2 crores in National Institute of Amateur Radio (NIAR) has not smoothly conducted due to the non-co-operation of the Director, and

(b) if so, the present stage of the enquiry and when it is likely to be completed?

A.-(a) Yes, The enquiry has not been completed so far. Due to delay in furnishing records to the Investigating Officer by National Institute fo Amateur Radio, the Investigating Officer could not peruse records collectede from the National Institute of Amateur Radio and the Relief Department.

(b) The enquiry is at the stage of verification of the records submitted by the National Institute of Amateur Radio and checking of ground balance of equipment at various places in Andhra Pradesh, such as Hyderabad, Bhadrachalam, Vijayawada, Nellore etc. The enquiry will be completed as early as possible.

ILLEGAL CONSTRUCTIONS IN MIRALAM TANK AREA

*1381-Q-Sarvasri K. Yerrannaidu, G. Vijaya Ramarao and B. Lakshman Rao:- Will the Minister for Revenue be pleased to state:

(a) whether it is a fact that illegal constructions are being made rapidly in Miralam Tank area of Hyderabad in collusion with the local municipal and Revenue officials; and

(b) if so, the steps taken by the Government to prevent such encroachers?

A.-(a) No, Sir. There was encroachment in the Miralam Tank area which was removed by the Municipal Corporation of Hyderabad authorities 7 months ago.

(b) No further development on the land. The land is under protection of Mandal Revenue Officer, Charminar Mandal, Hyderabad District. The Mandal Revenue Officer, Rajendranagar Mandal, Ranga Reddy District has also posted his staff for close watch to prevent such encroachments.

ILLEGAL OCCUPATION SINGADIKUNTA OF BANJARA HILLS

*1398-Q-Sarvasri K. Yerrannaidu and B. Lakshman Rao:- Will the Minister for Revenue be pleased to state:

(a) whether it is a fact that Government land in Singadikunta of Banjara Hills area is being sold away by a person called Manender a resident of Chintalabasti in connivance of the Government officials;

(b) whether it has been brought to the notice of the Government that a large number of pucca houses have been constructed in the entire valley of the said area; and

(c) if so, the steps taken to evict the encroacher and prevent sale of Government land?

A.-(a) Yes Sir. It is a fact that the Government land in Singadikunta of Banjara Hills is illegally occupied by certain individuals with the help of unsocial elements. It is also a fact that one Sri Mahender Yadav, resident of Chintalabasti and two others have illegally collected money from certain occupants of Government land in Singadikunta and they have also been threatening the occupants with dire consequences if they do not pay the money as demanded by them.

(b) No pucca houses have come up. 138 semi-pucca houses in on extent of 9281 Square Yards and (41) Kacha houses in 340 Square Yards have come up in the area.

(c) The demolition was taken up on 18.4.1987. In the meanwhile, the Welfare Association, Singadikunta Sasti represented by its Secretary, I.B. Laxman Rao and others have filed Writ Petition before the Honourable High Court of Andhra Pradesh, Hyderabad in the year 1987. The Honourable High Court directed not to demolish the huts situated in Singadikunta, on 10.12.1992. The W.P. No. 5440/87 is still pending. After conducting Socio-Economic Survey, Patta certificates for house sites were given to 127 eligible persons, who are staying away from the Tank Bed, on 15.8.95. Further, Station House Officer, Banjara Hills, Hyderabad was requested to take action against one Sri Mahender Yadav, (2) Pandu, and (3) Phool Singh who are involved in illegal encroachments.

ENCROACHMENT OF LAND BY VICEROY HOTEL

(b) whether the said land belongs to Sultan Bagh Masjid, Sajjad Ibrahim Sharief Darga and Hyderabad City Drinking Water and Sewerage Board.

(c) whether the said Hotel has converted the said land into garden; and

(d) if so, the action taken against the encroacher?

III) Assistance given to the victims of October, 1995

As soon as the warning was issued by the Meteorological Department about the impending low pressure and heavy rainfall forecast throughout the State, the administration in all the Districts swung into action to meet the contingencies. Timely action was initiated for evacuating the people living in low lying areas. Government had organised 395 Relief Camps, evacuated 45,954 families to safer places. 196 medical teams were formed and deployed in flood affected areas to provide and extend medical treatment to the affected people against Cholera, Gastroenteritis etc.

A total amount of Rs.61.75 crores has been released to the 19 Districts affected due to heavy rains and floods during October 1995 viz., (1) Srikakulam (2) Vizianagaram (3) Visakhapatnam (4) East Godavari (5) West Godavari (6) Krishna (7) Guntur (8) Prakasam (9) Cuddapah (10) Mahabubnagar (11) Ranga Reddy (12) Hyderabad (13) Nalgonda (14) Medak (15) Nizamabad (16) Warangal (17) Khammam (18) Karimnagar and (19) Adilabad for various relief measures.

Answer to clause (b):

A memorandum on damages or account of heavy rains and floods during October 1995 was submitted to Government of India seeking Central assistance to the tune of Rs. 195.52 crores in addition to the 10th Finance Commission allocation of Rs.17.2 crores under Calamity Relief Fund for 1995-96 towards restoration of public works/infrastructure and also relief to both small and medium farmers who have suffered extensive damages to their standing crops.

In addition to the Government of India was requested to consider the following requests to the State Government with its limited resources cannot meet these huge requirements in view of large scale damage to human lives, public and private properties.

1. To declare the present disaster as a National Calamity and extend generous help out of the National Fund for Disaster Relief;

2. To sanction and release additional amount of Rs. 180 crores over and above the Calamity Relief Fund allocated to the State out of the National Fund for Calamity Relief;

3. Allotment of additional sum of Rs. 100 crores under India Aardh Yojana for reconstruction of the 100 damaged houses;

4. To allow two lakh more of unskilled workers to be employed by Government of India in the public works programme to the benefit of the people in the affected areas.

5. To authorise the F.C.I. to open required number of counters for purchase of discoloured and damaged paddy/maize by relaxing quality procuremen norms; and

6. To order for reschedulement of Agricultural Loans etc., by the NABARD.

Central Team has visited the State from 12.11.95 to 14.11.95 and assessed the loss caused due to heavy rains and floods from 5.10.95 to 18.10.95 including the loss caused due to cyclonic storm on 8.11.1995 and 9.11.1995. Government of India have provided an additional amount of Rs.23.28 crores only to the state "as on account" advance payment of first quarterly instalment of grants-in-aid being the Centre's contribution to Calamity Relief Fund for 1996-97. The Senior Regional Manager, F.C.I. has informed that they have declared all their godown points as Paddy-Purchase Centres under price support.

A reply from Government of India in regard sanction of Central Assistance is still awaited. However, the Prime Minister of India has been pleased to sanction an amount of Rs.64.00 lakhs at the rate of Rs.50,000- to the bereaved families from out of Prime Minister's Relief Fund.

COMMUNITY HALL AT ZEEBABAGH

PROVIDING RADIOS TO VILLAGES

CONSTRUCTION OF BUILDINGS WITHOUT PERMISSION

(a) whether it is a fact that large number of buildings were constructed without permission and are awaiting regularisation in cities like Hyderabad, Visakhapatnam, Vijayawada and Tirupathi; if so, the details thereof?

In Visakhapatnam there are 4,406 unauthorised constructions, out of them 716 unauthorised constructions have been regularised and the balance of 3,690 are pending for regularisation. There were 4,147 unauthorised constructions in Vijayawada Municipal Corporation out of them 1,566 constructions were regularised and the balance of 3,581 are pending for regularisation.

There are 1,135 unauthorised constructions in Tirupathi Municipality out of them 33 cases were regularised and the remaining 1,102 are pending for regularisation.

(b) Yes, Sir.

(c) The number of buildings that are constructed in violation of Zoning regulations are 11,576.

**PROVISION FOR LOW ECONOMIC GROUP PEOPLE IN THE
LAYOUTS OF CO-OP HOUSING SOCIETIES**

KOTARAMACHANDRAPURAM, W.G. DIST.

*1985-Q-Sarvasri P. Janardhan Redd, M. Kodanda Reddy, Kanna Lakshminarayana and D. Nagender:- Will the Minister for Tribal Welfare be pleased to state:

(a) whether it is a fact that Project Officer, ITDA., is conducting Sadassu on every Wednesday at Kotaramachandrapuram, West Godavari District to receive representations from the Girijans;

(b) if so, whether the experiment have proved to be benefitted to the Girijans; and

(c) whether the Government will extend the said experiment to other ITDA also?

A.-(a) Yes, Sir. It is a fact that the Project Officer, ITDA, West Godavari is conducting "Grievances Day" on every Wednesday at Kotaramachandrapuram along with his sectoral officers to review various grievances and petitions received from the Girijans and solve their problems.

(b) Yes, Sir. It has been proved that it benefits the Girijans, since the representations received from the beneficiaries are examined and discussed with the sectoral officers concerned on the spot and they are informed of the action to be taken on the petitions and the time required for solving the problems on the same day itself. Thus the tribals are benefitted by the Grievances day at I.T.D.A. Kotaramachandrapuram.

(c) It is a practice in all the ITDAs., for over a decade by now to meet tribals on a fixed day which is mostly on a shandy (weekly market) day as tribals coming to the market can also utilise this opportunity to interact with the officers of the ITDA. Besides the Project Officers and other staff go to the villages and discuss various issues in Gram Sabhas regarding the schemes required, progress of ongoing schemes and problems in public distribution systems, marketing, health, education etc., Thus meetings with tribals is a regular affair in the I.T.D.As., for more than a decade now.

NON-FUNCTIONING OF T.C.R. & T.I.

*2015-Q-Sarvasri P. Janardhan Reddy and K. Bapi Raju:- Will the Minister for Tribal Welfare be pleased to state:

(a) whether it is a fact that the Paderu and Yatapaka Regional Centres of the Tribal Cultural Research and Training Institute, (TCR&TI) are not functioning;

(b) whether it is also a fact that the employees of the said centres have been drwing their salaries from these centres while working elsewhere; and

(c) if so, the steps taken by the Government to activate the said regional centres?

A.-(a) It is not a fact that the Regional Centres of Tribal Cultural Research and Training Institute, at Paderu and Yatapaka are not functioning. These two regional centres are functioning under the control of Project Officers, I.T.D.As. concerned to meet the Research Planning, Evaluation, training needs of the I.T.D.As. Employment oriented Training courses are also being organised at these Regional Centres.

(b) It is not true to say that the employees of the Regional Centres are working elsewhere. Whenever combined studies in collaboration with other agencies/institutions are taken up, the staff involved go to the field for collection of primary, secondary data, etc., to complete the study. The other studies entrusted to the regional centres are taken up and completed at their place of work only. Hence, it is not true that the employees working elsewhere are drawing their salaries from regional centres.

(c) The department has been taking all necessary steps to streamline the functioning of regional centres and the proposals are under consideration of the Government to fill up the posts of Joint Directors of regional centres.

**NON SPROUTING OF SEEDS SUPPLIED BY T.T.D.A.
I.F.A.D.**

*2198-Q-Sarvasri K. Yerram Naidu and S. Madhusudhana Chary:- Will the Minister for Tribal Welfare be pleased to state:

(a) whether Government have received any complaint that not even a single seed had sprouted out of the pineapple suckers and slips that have been purchased and supplied to the Girijans under the ITDA., IFAD., scheme for the season of 1995-96 in the Seethampetaa Centre, Sriakulam District as they are of very poor quality;

(b) whether 750 plants of Kerala variety and 500 plants of Simhachalam variety were supplied to the Girijans in the Revenue villages;

(c) whether officers of Horticulture and ITDA indulged in corrupt practices and prepared bills hurriedly for Rs.4.80 lakhs for pine-apple suckers and Rs. 8 lakhs for slips and cheated the Girijans; and

A.-(a) No, Sir. no complaints were received from any of the tribalk beneficiaries to whom the pineapple suckers and slips were supplied about the non-sprouting of the pine-apple plant material supplied to them

(b) Yes, Sir. 750 plants of Simhachalam variety and 500 plants of Kerala variety were supplied to each of the tribal beneficiaries in 15 villages as per the approved action plan under A.P. Tribal Development Project assisted by IFAD and ITDA., Action Plan 1995-96.

(c) There were complaints from the local press and the local tribal leaders about the alleged irregularities in the purchase and distribution of pineapple plant material and therefore the Project Officer, I.T.D.A., Seethampeta was appointed as the Enquiry Officer to conduct a detailed enquiry into the reported allegations. The involvement of Horticulture Department and ITDA., Officials in any corrupt practices can only be established in the detailed enquiry.

(d) The Joint Collector, Srikakulam has conducted a preliminary enquiry on the reported allegations and furnished report to the District Collector and Chairman, ITDA. The Chairman has initiated action based on the preliminary enquiry report and accordingly the Project Horticultural offices was surrendered to his parent Department and services of Agricultural Development Consultant were terminated. The Chairman has instructed the Project Officer, ITDA to conduct a detailed enquiry and the Enquiry Officer has proposed to conduct a detailed field level enquiry during Prajala Vaddaku Palana and also since the Enquiry Officer is also the Nodal Officer for Seethampeta Mandal.

PENSION TO HANDLOOM WEAVERS

A.-(a) Yes, Sir.

(b) Family pension scheme for Handloom Weavers is implemented with effect from 11.1994.

The salient features of the scheme are as follows:

(i) The scheme is extended to all the active weavers members of age group 18-58 of the Cooperative Societies in the State;

(ii) The Government will subscribe at the rate of Rs.- 25/- per annum per member for all the members admitted under the scheme towards Family Pension Fund;

(iii) In the event of death of a member, below 58 years of age, the nominee/legal heir will be paid Rs.250/- per month towards Family Pension for a maximum period of 10(ten) years.

The State Government had released Rs.9.60 lakhs to implement the scheme during the year 1993-94. So far, 7,874 Weaver members are enrolled under the scheme.

(c) The scheme of workshed-cum-Houses/Worksheds is implemented from 1985-86 to Handloom Weavers Co-operative Societies and the target to achieve is 25,000 worksheds-cum-Houses/worksheds by the end of eighth plan. The weavers of Co-operative Societies are assisted at Rs.2,000/- per weaver whose annual income is below Rs.2,500/- under the scheme of Margin Money for Destitute Weavers.

(d) From the year 1993-94 to 1995-96, so far 9230 weavers of 185 weavers co-operative Societies are given financial assistance to an extent of Rs.117.10 lakhs under scheme of Margin Money for Destitute Weavers. From the year 1985-86 to 1994-95, 10,311 workshed-cum-Houses and 7,813 worksheds total 18,124 are sanctioned to weavers of cooperative societies during 1995-96 it is proposed to construct 500 workshed cum-Houses and 2,000 worksheds.

Then sufficiently 60% of the land is available for allotment to the earlier previous and industrialists. It is therefore inevitable for the corporation to reckon this factor in its pricing policy.

**CONSTRUCTION OF POLICE STADIUM, BUILDING
IN KAVALI, NELLORE DISTRICT.**

2027-Q-Sarvasri S. Chandra Mohand Reddy, G. Veera Siva Reddy, Smt. Yerneni Sita Devi, Sarvasri B. Narasimhulu, K. Yerram Naidu, C. Krishna Yadav and B. Narsimhulu:- Will the Minister for Home be pleased to state:

(a) whether the construction of Police Stadium Building in Kavali of Nellore District has been stopped after spending an amount of nearly Rs. 3 lakhs.

(b) whether it is a fact that the contractor has been paid only Rs. 2 lakhs.

(c) whether orders have been issued to start the work again which has been stopped 2 years ago when the contractor insisted for the payment of the balance amount of Rs.1 lakh, and

(d) the reasons for stopping the work and who is responsible for excess expenditure?

A.-(a) No Police Stadium Building at Kavali of Nellore District was taken up for construction. However, Police Station Building at Kavali was taken up by Andhra Pradesh State Police Housing Corporation Limited and the work was stopped at First Floor Roof level and on this account an amount of Rs.3,64,696-14 was incurred. Further, the Grouped Floor of the Police Station Building was already constructed and handed over to the Police Department on 20.1.1995.

(b) Yes, Sir.

(c) No, Sir.

(d) According to the construction programme of Police Station buildings, in the year 1983, Government intended to construct 330 number of Police Station Buildings through the Andhra Pradesh State Police Housing Corporation Limited. Subsequently, during the year 1993, the number of Police Station Buildings were restricted to 228 only as the commitments for the Police Station Buildings were too heavy. As a result certain Police Station Buildings including the Police Station Building, Kavali were to be curtailed. In the circumstances the question of responsibility for incurring the excess expenditure does not arise.

REPAIRING OF DEFECT AND DEFUNCT BOREWELLS

783-Q-Sri D.S. Redyanaik:- Will the Minister for Panchayat Raj be pleased to state:

(a) whether the Government have taken up crash programme under which all defective and defunct borewells will be repaired in all villages in the State:

(b) whether any survey has been conducted to identify new points where bore wells could be sunk; and

(c) if so, the places identified in each district;

A.-(a) In order to ensure that all the hand pumps in the villages of the State are kept in working condition and to meet the drinking water requirements, especially during the summer season, the department is launching a crash programme for maintenance of hand pumps every year. The crash programme is conducted for about 45 days during December-February to check up and attend to the maintenance of hand pumps in the State. Action plans will be formulated by the Superintendent Engineers/Executive Engineers(P.R.) to cover all the villages and check up the hand pumps during the crash programme. During this year the crash programme was launched from 1.1.95 to 15.2.95. During crash programme, 11,000 major repairs and 16,939 minor repairs were carried out to the hand pumps in the State.

(b) The Department geologist after systematic hydrogeological/geophysical survey, are identifying the sources to be drilled in the villages in various districts as per need.

(c) The list showing the number places identified in each district and borewells completed under drought during 1994-95 and 1995-96 in appended.

(b) An extent of 63.70 Kms. length of roads damaged in Uravakonda Constituency.

(c) An amount of Rs.1172.50 lakhs was spent during last five years (i.e., 1990-91 to 1994-95) in Ananthapur District and particularly an amount of Rs.169.30 lakhs was spent for Uravakonda Constituency. An amount of Rs.490.00 lakhs was allotted for the financial year 1995-96, for Ananthapur District under Rural Roads Maintenance grant.

DRINKING WATER PROBLEM IN INDURTHI CONSTITUENCY

1362-Q-Sri D. China Mallaiah:- Will the Minister for Panchayat Raj and Rural Development be pleased to state:

(a) whether the Government are aware of the fact that Indurthi Constituency in Karimnagar District is famine effected area;

(b) whether some bores have been sanctioned for solving the problems of drinking water;

(c) whether it is a fact that some of the drinking water schemes are not proving beneficial to the public due to several reasons like incompletion of some mini P.W.R.S. Schemes and S. A.P.S., shortage of pipe lines, lack of O.H.S.R. and current motors and failure of bores;

(d) whether the local legislator has submitted a representation requesting to sanction Rs.1.60 lakhs for the completion of those schemes; and

(e) if so, the reasons for not sanctioning the same?

A.-(a) No Sir. Indurthy Constituency in Karimnagar District is not declared as famine affected area.

(b) Yes Sir, 113 borewells have been sanctioned in Indurthy Constituency (i.e., in 4-Mandala of Husnabad, Koheda, Chigurumamidi and Bajjanki) during 1994-95 and 1995-96 under different grants. List of 113 Borewells is herewith enclosed (Annexure-I). All the borewells were drilled fitted with Hand pumps and functioning properly,

(c) Most of the schemes are functioning but extension of pipelines for full coverage is to be laid for which sanctions are obtained under different programmes noted against each. Only in respect of (7) habitations i.e., (1) Potharam of Husnabad(M) (2) Chigurumamidi (3) Regonda (4) Mulkanoor of Chigurumamidi(M) (5) Gandlapalli (6) Hamajipalli (7) Vadloor of Bajjanki(M) scheme are not functioning as sources dried up and necessary sanction providing alternative sources are obtained for rejuvenating the scheme under the grant noted against them (Annexure - II).

In respect of the scheme of Laxmipur H/o Nagasamurara of Koheda(M) power connection is to be obtained and issued instructions to the Superintending Engineer(PR) Karimnagar to commission the plant before 29.2.1996.

(d) Yes Sir. as explained under item-c necessary sanctions were already given under different grants and details given in Annexure-II. The balance schemes are proposed to be taken up in a phased manner and the details are appended in Annexure III.

(e) Sanctions will be given in phased manner to cover all the balance habitations.

**REGULARISATION OF SERVICES OF PART-TIME
STAFF WORKING IN GRAM PANCHAYATS.**

1958-Q-Sri S. Chandra Mohan:- Will the Minister for Panchayat Raj be pleased to state:

(a) whether it is a fact that the services of some of the part-time staff working in Gram Panchayats, who are having all the qualifications as per G.O.Ms.No. 212, Finance and Planning (PC.III) Department, dt. 22.4.94 have not been regularised; and

(b) if so, the steps to be taken by the Government to regularise their services?

A.-(a) It is a fact that the services of part time employees working in Gram Panchayat who are having all the qualifications as per G.O.Ms.No. 212, Fin. Dt. 22.4.94 were not regularised because there are no clear vacancies to absorb all the part time employees working in different Gram Panchayats. The Government has prescribed staffing pattern rules in G.O. Ms.No. 859, Dt. 30.8.77 and certain instructions for creation/conversion/upgradation of posts in the Gram Panchayats in G.O.Ms.No. 491, Dt. 4.10.86 and in G.O.Ms.No. 176 dt. 23.3.88 the expenditure on the staff should not exceed 30% of tax and non-tax revenue of the Gram Panchayat (Non notified). Apart from the conditions stipulated in G.O.Ms.No.212, Fin. Dt. 22.4.94 the part time employees would also fulfill the conditions as stipulated in the above said G.Os.

(b) Depending upon the vacancies the part time employees are being given the time scale and their services are also being regularised.

FLOURINE CONTENT IN DRINKING WATER IN NALGONDA DISTRICT

2362 - (11) - Q-Sarvasri K. Yerram Naidu, N. Narasimha Reddy, N. Raghava Reddy and J. Ranga Reddy:- Will the Minister for Panchayat Raj and Rural Development be pleased to state:

(a) whether it is a fact that the Government identified eight years ago that there is flourine content in the drinking water in Dattayapalli, Nagayapalli and Kondapuram villages in Turkapalli Mandal in Nalgonda District and provided flourine filters; and

(b) if so, why the bores which have gone out of order were not repaired and more flourine filters are not provided?

A.-(a) Yes, Sir.

(b) These HPDF plants were installed by Government of India through NIDC and handed over to Gram Panchayats for maintenance. The Gram Panchayats have not maintained these plants properly and disconnected the plant from the hand pump

as the public found it hard to operate hand pump. The hand pump have been repaired and they are working.

An expert committee set-up by the Government of India for evaluation of these plants wanted the following modifications to be done for the proper functioning of the plants.

- 1) Improvements to dosing device
- 2) To extend detention period for proper defluoridation
- 3) To provide improved filters.

Government of India has sanctioned three pilot projects under which these plants are proposed to be repaired and rejuvenated under the guidance of NEERI. Only after carrying out the repairs and if the plant functions properly more plants will be installed.

Professor and Head of the Department of Urology, NIMS have been received. Keeping in view the gravity of the allegations, a judicial inquiry has been instituted. Orders have therefore been issued in G.O.Ms.No. 433 M & H(E2) Department, dated 21.11.95 appointing Sri A. Vengal Reddy, District and Sessions Judge (Retd.) as the Commission of Inquiry, to inquire into alleged molestation of Miss. Farzana by Dr. B. Suryaprakash. The Commission of Inquiry has assumed charge on 01.12.1995. Meanwhile Smt. Noorjahan Begum mother of Miss. Farzana has filed a W.P. No. 30147/95 before the Hon'ble High Court pleading that the Commission of Inquiry is constituted to inquire into the molestation against Miss. Farzana and whereas Dr. B. Suryaprakash has committed a rape against her and that a case in Crime No. 586/95 under Section 376 IPC is registered at Panjagutta Police Station to that extent. She has therefore requested to appoint a fresh Commission or Inquiry to inquire into the rape against the victim, the Hon'ble High Court in their orders in the W.P.M.P. No. 37137/95 in W.P. No. 30147/95 filed by Smt. Noorjahan Begum dated 03.1.1996, stayed the commencement of the Commission of Inquiry from 04.1.1996 in pursuance of the orders issued in G.O.Ms.No. 433 M & H, dated 21.11.1996.

The Government have examined the matter and issued in orders in G.O.Ms.No. 73, HM & FW, dated 13.2.1996 amending the G.O.Ms.No. 433, HM & FW, dated 21.11.1995 for the wording "Molestation" to that of "Rape/Molestation", wherever it occurred. A.-(a) Yes, Sir. Drinking Water is polluted in case of

**CLOSURE OF SEETHAMPET MILK CHILLING PLANT
IN SRIKAKULAM DISTRICT**

Development and Fisheries be pleased to state:

(a) whether a Milk Chilling Plant was established at
Seethampet Mandal Head Quarters in 1977, which was serving
Bhimini and Kothur Mandals in Srikakulam District.

(b) whether although there are no milch animals in
Seethampet Tribal Mandal, 650 litres of Milk was collected
every day from Bhamini and Kothur Mandals;

(c) if so, why it is being closed down now for a Second
time; and

(d) whether it is not possible for ITDA Authorities to
develop it by training the tribals in Dairy?

A.-(a) Yes, Sir;

(b) Yes, Sir;

(c) On running the Milk Chilling Centre, Seethampet, it is experienced that there is no improvement in milk procurement and rather it has shown fall. On the other hand, the operational charges have increased, as high as about Rs.4.54 per litre resulting in the non-viability of running the Milk Chilling Centre at Seethampet, Due to Un-economical functioning, the Milk Chilling Centre at Seethampet was closed on 30.6.95. However arrangements have been made to procure Milk from Bhamini and Kothuru Mandals which were supplying milk to Milk Chilling Centre, Seethampet by diverting the routes to Milk Chilling Centre, Srikakulam so as to see that the Milk products are not affected.

(d) The ITDA authorities have already tried many a time to develop the milk production base in tribal areas but in vain.

RECOGNITION OF VADDERA, DOMMERA AS SCHEDULED TRIBES

(b) No, Sir. Vaddera and Dommera Castes are not recognised as Scheduled Castes in the states of Karnataka and Tamilnadu as per SC and ST Orders (Amendment) Act, 1976.

TURNOVER OF GIRIJAN COOP-CORPORATION

1866-Q-Sri D.S. Redyanaik:- Will the Minister for Tribal Welfare be pleased to state:

(a) the total turnover of Girijan Cooperative Corporation (GCC) for selling Minor Forest Produce and Agricultural produce during 1994-95.

(b) whether there is any proposal to increase the same during the year 1995-96; and

(c) the action taken by the Government for the economic up lift of tribals and rescue them from the clutches of middlemen?

A.-(a) The total turnover of Girijan Co-operative Corporation for selling Minor Forest Produce and Agricultural Produce during 1994-95 is Rs.1294.24 lakhs, out of which Rs.1161.46 lakhs(MFP) and Rs. 132.78 lakhs (Agricultural Produce).

(b) The budget on sale of M.F.P. for the year 1995-96 is Rs.1600.00 lakhs and for Agricultural Produce is Rs.505.00 lakhs. Hence there will be an increase in turnover of both. (A Comparative statement is enclosed as Annexure).

(c) Girijan Co-operative Corporation is an apex Co-operative body to the 45 affiliated GPCM Societies. The activities of the Girijan Co-operative Corporation are:

- 1) to purchase out right Minor Forest Produce on monopoly basis from tribals by paying a fair price.
- 2) to supply all their Domestic requirements at cheaper rates.
- 3) to meet their credit requirements from Agriculture development.

In order to achieve the first objective, Girijan Co-operative Corporation is appointed as an agent to Government in procurement and marketing of M.F.P. and 25 items are entrusted on monopoly procurement. To provide remunerative prices to the tribals engaged in collection of M.F.P. Government is subsidising the cost of Forest rentals by book adjustment to Forest Department on behalf of Girijan Co-operative Corporation. Government also subsidising the establishment cost of Girijan Co-operative Corporation and GPCM Societies as per G.O.Ms.No. 112 Social Welfare (S2) Department dt.8.7.94.

Government has exempted GCC in payment of Market Cess on MFP and APGST in procurement and marketing of MFP., AP and DRs. By opening 750 D.R. Depots throughout the tribal areas of the Andhra Pradesh. Essential Commodities and other daily requirements are being provided at the door-steps of the tribals. GCC has taken up Season Agriculture Operations loaning programme since 1990 and is meeting credit requirement of tribals in a phased manner.
